ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis and Whippets may be entered in the regular stakes. Limited and Provisional Stake breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Silken Windhounds and Portuguese Podengo (all three varieties). All entries shall be individually registered with the American Kennel Club, the National Greyhound Association, the United Kennel Club, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake breeds shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

STAKES OFFERED:

OPEN STAKE: Any eligible sighthound that has met the certification requirements, excluding ASFA Field Champions of Record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: : Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ridgebacks and Whippets whose age shall be at least seven years.

SINGLE: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field.

LIMITED: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.

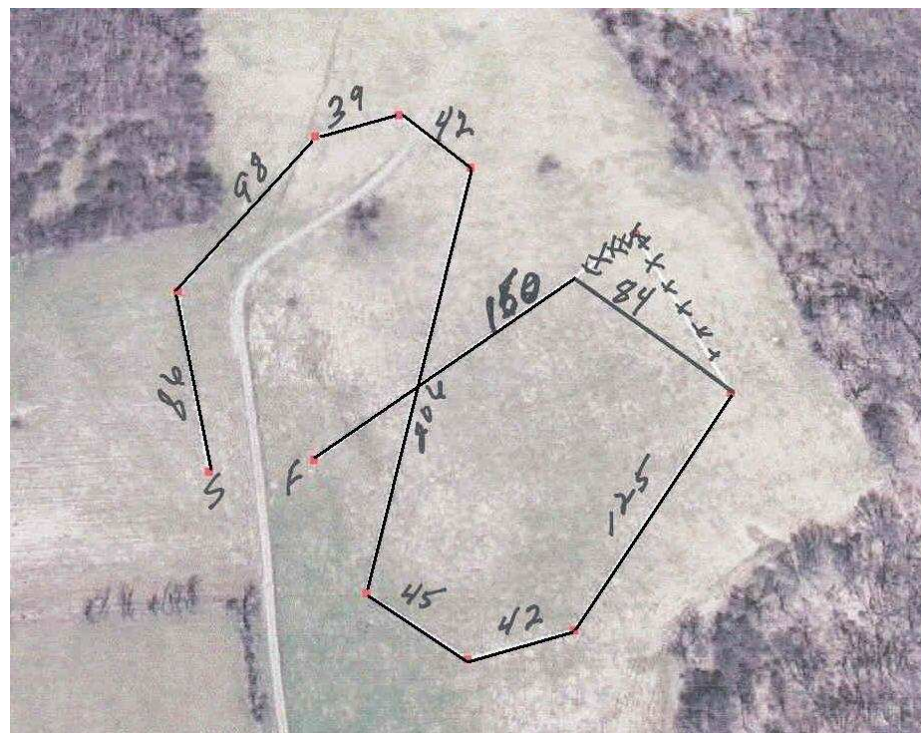

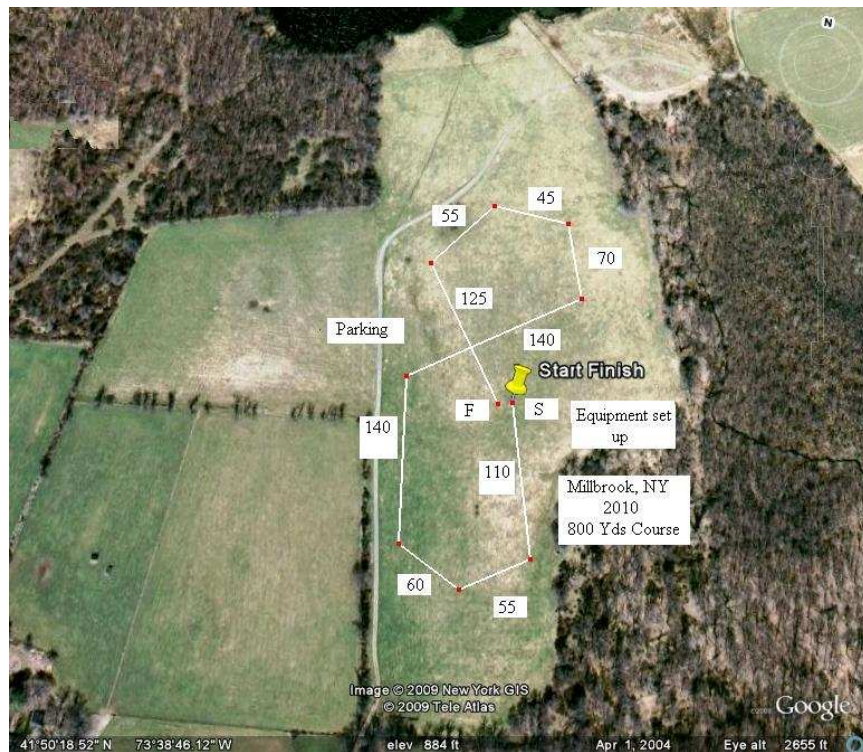
CONDITIONS OF ENTRY

*Hounds must be one year or older on the day of the trial and will be examined for breed disqualifications – spayed, neutered, monorchid and cryptorchid hounds without breed disqualifications may be entered *Hounds with breed disqualifications are not eligible to enter except in the Single Stake *Stakes will be split by random draw if the entry in any one stake is 20 or more at the time of the draw *All hounds will run twice, in trios if possible, or braces unless excused, dismissed or disqualified *Bitches in season, hounds with breed disqualifications and lame hounds will be excused *Hounds not present at Roll Call will be scratched *A battery powered, continuous loop machine will be used *The lure will consist of highly visible plastic strips *The course will be reversed for the finals, run-offs, Best of Breed, Best in Field *The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial *Participants should provide their own shade, water and food *There will be a \$5 fine for any hound loose on the field during another hounds' course and for participants not cleaning up after their hounds

DIRECTIONS TO THE FIELD

From Boston or Eastern New England:

Take Mass Pike (RT 90) West, crossing in New York State. Take Exit B3 (RT 22) towards Austerlitz/New Lebanon. Turn left on NY 22. Take Exit for US 44 / West Main St. Continue on RT 44 for approx 4.8 miles. Turn right onto Shunpike / CR 57. Field approx 1.8 miles on right.

From the Taconic Parkway (southbound):

Turn East onto North Rd, which becomes CR53. After approx 7 miles, turn right onto NY 82, which becomes Millin Ln./CR87. In less than a mile, turn left onto Hunns Lake Rd/CR65, then right onto CR86/Bangall Amenia Rd/James Cagney Way, and then turn left to stay on that road. After approx 2.5 miles, continue onto Shuman Rd, which becomes Ludlow Rd. After approx 2 miles, turn left onto Shunpike. The field is on your left.

From the Taconic Parkway (northbound):

Take US 44 east approx 0.5 miles. Turn left onto NY 82. After approx 3.5 miles, turn right onto Shunpike. The field is on your left in approx 5 miles.

From CT:

Take CT 4, which becomes NY 343. Approx 2 miles from the border, stay straight onto US 44. After approx 4.5 miles, turn right onto Shunpike. The field will be on your right after approx 1.5 miles.
